

TEACHER AGREEMENT

Parties:

THIS AGREEMENT is made by and between CRIMSON CIRCLE ENERGY COMPANY, INC., a Nevada corporation, of 341 Ski Way, Suite 103, Incline Village, Nevada 89451 USA (hereinafter "CCEC") and (name), (hereinafter "Teacher") of..... (address), with _____ US tax ID Number if applicable and jointly hereinafter "Parties."

Term:

THIS AGREEMENT is an "at will" agreement between the Parties. Either may terminate it with or without cause on twenty-four (24) hours' notice. The term of this Agreement starts upon signing and terminates as noted herein.

Relationship, Valid Agreement:

Teacher is an independent contractor. As such, Teacher is responsible for his/her own state and local licensing, all taxes, expenses and insurance. CCEC will not make any payments on Teacher's behalf to any federal, state or local governments or any third parties.

For this Agreement to remain valid, Teacher must hold a valid Teaching Certificate from Shaumbra Institute, Inc., a subsidiary of Crimson Circle Energy Company, Inc. Shaumbra Institute reserves the right to review and modify Teacher qualifications at any time.

Classes:

Teacher will conduct his/her classes in accordance with the materials and guidelines provided by CCEC. Teacher shall not modify the teaching materials provided by CCEC in any way or use outside of an approved class;

Class listings and student registrations need to be administrated through the Crimson Circle website. Classes shall not be held in a private residence, unless a waiver is obtained, which shall not be unreasonably withheld.

CCEC may require two (2) certified co-Teachers for certain schools or class sizes.

Classes cannot be cancelled without permission of CCEC.

Financial Terms:

All gross revenues shall be paid into CCEC. The proceeds of such revenues shall be split: 70% to Teacher and 30% to CCEC. Each party shall be responsible for their respective taxes on said sums.

In the event of co-Teachers, Teachers' gross revenue shall be split equally among Teachers

unless the Teachers agree to a different split in writing.

Materials Protected:

CCEC shall provide two (2) sets of teaching materials to Teacher. All materials remain the property of CCEC and shall be returned to CCEC upon demand. Teacher acknowledges that the materials contain specialized intellectual property that has substantial value to CCEC. Teacher agrees to not copy, redistribute or use same unless in accordance with the express direction of CCEC. Any teaching materials which are trademarked, service marked or copyrighted expressly remain the property of CCIP, Inc., Geoffrey Hoppe or other affiliated owner of such rights. Teacher irrevocably appoints CCEC as his/her attorney in fact to prosecute any claims of trademark, service mark or copyright or other intellectual property infringement of CCEC's property.

Disputes:

Any dispute arising from this Agreement shall be resolved by the use of Binding Arbitration in accordance with the provisions of Nevada Revised Statutes Chapter 38.

Entire Agreement; Amendments in Writing, Applicable Law:

This is the entire Agreement between CCEC and Teacher. Amendments can only be made in writing.

The laws of the State of Nevada, United States of America, including conflict of laws, choice of law and choice of jurisdiction provisions, shall govern this Agreement in any dispute arising hereunder. Venue for any action to enforce the terms hereof shall be in Washoe County, Nevada.
